
YOUR FINANCIAL CHAMPION 2022 Annual Report

MSGCU has reached where we are today and is able to continually give back because of all of you, our members. We were pleased to welcome 18,276 new members to the MSGCU family, which reached 142,842 members at the end of 2022.

First Place, for the creation of an online financial literacy program to serve students earning a high school diploma or GED at My Virtual Academy.

Member and Community Support

Classroom Cash Grants: Awarded \$45,142 in grants to 63 educators representing 49 schools across the Metro Detroit area. The grants, worth up to \$750 each, help with the implementation of innovative learning experiences.

Scholarships: \$116,500 was granted in 2022 through scholarships to help offset the costs of education. Scholarships were awarded to 49 recipients including high school seniors, students studying education and skilled trades, teachers furthering their education, and future first responders.

Community Partnerships: Partnered with schools, libraries, businesses, and community centers, hosting 260 virtual and in-person financial education workshops, 11 student reality fairs, and helping over 19,342 community members increase their financial literacy.

Team Member Service: Prepared 4,000 bags for Gleaners Food Bank food drive, gave 32 pints of blood to the American Red Cross, and donated \$6,900 to Vets Returning Home, Humane Society of Huron Valley, Children's Hospital of Michigan, and Oakland County Foster Closet.

Giving Back: Donated \$17,000 through partnerships with local organizations serving our communities such as multiple fire and police departments in Southeastern Michigan, New Baltimore Parks & Recreation, Clinton-Macomb Public Library, and St. Clair Shores Optimist Club.

Library Grants: Donated \$69,000 to 92 schools after discovering that many library shelves were depleted due to unreturned books following remote learning during the COVID-19 Pandemic, as well as the request to provide books which reflect diversity of experiences and perspectives across the country and around the globe.


Ukraine Support: Donated \$15,000 to provide medical supplies and clothing for Ukrainian refugees.

CU Lunch Local: Participated in an industry-wide cash mob by purchasing \$3,536 worth of lunch from locally owned restaurants on October 18.






